PDG Adrienne Bzura Recognized by Rotary International

Past District Governor Adrienne J. Bzura, of the Rotary Club of Old Bridge-Sayreville, has been named by Rotary International President-Elect John Germ to serve as a member of the RI Constitution & Bylaws Committee. This three-year commitment will begin on July 1st and continue through June 30, 2019.

This decision by RIPE Germ was made following a thorough review of more than 1,000 applications

received from clubs and districts worldwide. There was only one opening available on the committee, whose other three members are from India, Korea, and Columbia. Adrienne is not only the first Rotarian from District 7510 to serve on this committee, but she is also the <u>first woman in Rotary history</u> to do so.

Further, Adrienne has also been informed that in 2019 she will serve as the Chair of the Constitution and ByLaws Committee of the RI Council on Legislation. This constitutes two remarkable "firsts" in RI and District history.

Such exceptional service to Rotary isn't new to Adrienne. In 2000-01, she served as the first woman District Governor of District 7510, to be followed by

four equally outstanding women Rotarians: Marsha Carldon (2002-03), Frieda Applegate (2004-05), Julia Ann Juliano (2007-08), and Megan Jones-Holt (2011-12).

Adrienne is the only Rotarian from District 7510 to have served on Zone Foundation Committees,

District Foundation Grants Ready to Roll!

We had a great District Assembly on April 27 that was well-attended by representatives from many of our clubs. I want to share with everyone some of the information that we presented about what your club needs to do to participate in our Foundation activities and to receive a Foundation grant.

To follow up on the Foundation remarks at the District Assembly:

1. Club **Presidents**: Please appoint a Club Foundation Chair and register them in DACdb. (Also, connect your DACdb to rotary.org, so the two databases are linked.)

2. Club Presidents and Foundation Chairs: Please apply for a club grant of \$500. You can increase the grant by matching it dollar for dollar up to another \$500, for a total of \$1,500:

This would be \$1,000 from the District and \$500 from your club. Think of a worthwhile project in which to use the funds.

The Deadline is July 15th. The money is not helping anyone by sitting n the bank- let's put it to good use.

Log-in to DaCdb and click on the Grants tab. Filing your application is now paperless!!

3. Club Boards of Directors: Please add \$100 per member to your July 1st invoice of Annual Club Dues for a voluntary, optional, tax deductible donation to the Rotary Foundation. Add it to the total at the bottom. If the member does not wish to contribute, they can cross it off and deduct the \$100 from the total.

Half of the clubs currently include this with their annual dues; and almost everyone in those clubs contributes. The club treasurer can send one check to the Foundation with a letter telling them which members to credit.

This is our Charity as Rotarians. We all give to charities in general. We should all give to our Rotary Charity.

4. Club Program Chairs: Please ask Byron Miller to come to your club for a program on the Rotary Foundation. He is an excellent speaker and you will learn a lot about the Rotary Foundation.

Thanks for your help in these matters, Looking forward to a good next year with Charlie as Governor.

Foundation Grants Available Byron Miller

The Rotary Foundation returns money to our District every year that the District then makes available in the form of grants for club projects. This should be "old news" to our clubs. However, what is "new news" is that the guaranteed minimum is \$500 per club for a qualifying project or projects, and the maximum is \$1,500. Also, for the next grant cycle, clubs will fill out their grant applications on-line in DaCdb, the District and Club database.

The District is using a new "Grants Module" to help streamline the process of submitting, approving, and awarding grants for the 2016-2017 year.

We are guaranteeing that every club will receive a minimum of \$500 for a qualifying project. That is the minimum, and the maximum that may be awarded is \$1,500! But the even better news is that you can partner with another club or clubs and pool your rescources and your grant awards to accomplish even bigger projects. One club will complete the grant application on-line, and will identify the partner clubs in that application. If you want to partner with another lead club, simply make the committment to that lead club and they will do the rest.

At PETS 1, our Foundation Grants Subcommittee presented information on grant availability and answered questions from presidents-elect. The subcommittee also handed out the paperwork necessary for clubs to qualify for receiving grants.

The next phase of the project is for clubs to decide on their grant-eligible projects and submit their applications on-line at DaCdb – www.directory-online.com/Rotary.

Our friends at DaCdb have made a handy overview/guide available – you can download "District Grant Management Guidelines" on the District website under "About 7510" here - http://www.rotarynj.org/ forms-and-resources.php.

.After reviewing the guide, you can gather your information and then proceed to the Grants Module and follow the steps to submit your grants.

We have District representatives ready to review your applications and assist as needed in filing the correct information.

Don't wait! File your applications as soon as possible, but no later than July 15, 2016.

One Year After Nepal Earthquake

A message from Anil Maharjan on the first year of Homes of Hope - Nepal, our month in Nepal, and the future.

Nearly a year after the earthquake, our team had the opportunity to spend a month traveling Nepal. There are obvious reminders of the disaster when you see temporary shelters, buildings being held up with wood beams, caved in roofs, and piles of debris. There are also less obvious reminders, parts of everyday life that have been altered due to the political instability following the disaster: hundreds of cars queueing for gasoline, people burning wood to cook their dinner, and endless youth waiting for visas to work abroad.

Yet, there is still the endless positivity of the Nepali, which, coupled with their pride in and love for their nation, provide the sort of optimism that is needed amongst these reminders. For every negative distraction, there was a group of Nepalis looking to make the country a better place.

It is with these individuals that will we be partnering, not only over the next year, but as far as the foreseeable future might bring us. While we were able to provide some money for these projects, we can only be there so many days out of the year. The legacy that we hope to leave is one that empowers other Nepalis to make their communities as perfect as they can imagine them.

This is why we will be expanding our project beyond just home building. We will be extending our focus to include: micro-credit lending, education, and home building. We want to provide hope at every major junction in one's life.

We will continue to evolve with the changing situation in Nepal, but we will do so with the guidance of our friends and partners in the country. We recognize that we will never be the largest organization, but we will always be the one that ceaselessly inspires.

Our Rotary friends have been a part of our success and I cannot begin to thank you for all that you have done to support our cause.

Council on Legislation 2016 Report #1

The Council on Legislation is held every three years with representatives from every Rotary district gathering to consider proposed Enactments (rule changes) and Resolutions (recommendations to the Rotary International Board). The recent Council on Legislation has been tagged as possibly the most progressive in history. There were many enactments passed that will reshape how Rotary functions. I would like to give you an overview of two that will make a difference to all of us.

Enactment 16-21 was passed by a vote of 392 for and 82 against. This enactment will provide flexibility in the clubs' bylaws to determine the provisions for meeting frequency and attendance.

Enactment 16-36 was passed by a vote of 386 for and 75 against. This enactment will provide Rotary Clubs the flexibility to remove or modify the membership classification system in their clubs bylaws and to modify some of the provisions regarding membership.

The ROTARY LEADERSHIP INSTITUTE ("RLI") is a multi-district, grass-roots leadership development program of over 370 member districts (that's 70 percent of all Rotary districts world-wide). RLI is organized into regional divisions; District 7510 is a member district of RLI of Northeastern America (the website is http://www.rlinea.org/).

RLI's Founder and International Chair, David Linett, is a Past Governor of this District (1991-92), and former member of the Rotary Club of Somerville & Bridgewater.
